Sponsor the 3rd Annual Indigenous Cannabis Industry Association Washington DC Policy Summit

The Indigenous Cannabis Industry Association (ICIA) will be hosting its 3rd annual Washington DC Policy Summit where we will bring together elected tribal officials, legal and medical professionals, cultivators, processors, and advocates to discuss the future of cannabis as medicine and the significant role cannabis can play in health care and economic development for Indian Country. The Summit will be taking place November 13-15th in Washington, DC with a location to be announced shortly.

At our DC Policy Summit, experts and panelists will discuss the potential role of cannabis in closing the American Indian/Alaskan Native and Native Hawaiian Health Disparity Gap, while addressing the Indigenous history of cannabis prohibition, and the devastating effects and lasting impressions prohibition has left on communities of color and how we can advance self-determination and sovereignty to address equity in cannabis reform. We will explore common myths about cannabis which pose barriers to consideration by people and communities of color, and introduce the attendees to our network of national professionals and business owners who are blazing trails and sharing their journeys to our members. The Summit will kick off with a tribal regulators and leaders meeting to discuss the issues and unify on solutions faced at the local, state and federal levels. That evening there will be a welcome reception before a full day of cannabis policy immersion. Day two will end with a gala reception where we will announce our annual award winners- stay tuned for nomination information. Day three will jump start with a coffee and breakfast hour and lobby day boot camp before a half day of high impact meetings with our Congressional Representatives.
